

# Acomo announces the resignation of Non-Executive director Victoria Vandeputte

**ROTTERDAM (NL), 30 DECEMBER 2025**

Today, ACOMO N.V. (Acomo), the Euronext Amsterdam-listed diversified, plant-based food ingredients Group, announces the resignation of Non-Executive director Victoria Vandeputte (54, photo) as per 1 January 2026. She was appointed Non-Executive Director of Acomo in September 2021.

In a brief statement she explained: "I have notified the Board that, as my engagements with other companies evolve, there is a growing potential that I might not be able to combine in the future such engagements with my role as Director of Acomo. I felt it is appropriate to make room for a new Non-Executive Director. I thank the Board and management teams of the various Acomo Group companies for their cooperation and the constructive work we have accomplished together to further prepare and guide Acomo on its mission 'Building routes to healthier foods'.

Bernard Stuivinga, Chairman of the Board said: 'We have taken note of and respect Victoria's decision to step down from her position. We are most grateful to her for her valuable contributions as a Board member. As a consequence of the decision, we will present her successor within the next months, most likely before the Annual General Meeting (AGM) to be held on 24 April 2026.'

Effective 1 January 2026, the Acomo Board consists of the following members: Bernard Stuivinga (Non-Executive Chairman), Machtelt Groothuis (Non-Executive Director), Bert Meulman (Non-Executive Director), Jan Niessen (Non-Executive Director), Allard Goldschmeding (Executive Director/ CEO) and Mirjam van Thiel (Executive Director/CFO).
